## 1. Call to Order - Chair Mark Salinas

Chair Salinas called the meeting to order at 5:36 p.m.

## 2. Roll Call – Vice Chair/Secretary Pat Gacoscos

It was noted that Chief Boykins and Mr. Van Buren were unable to attend.

## 3. Foundation contribution to GO Bond - Measure A campaign - President Sperling

President Sperling made a presentation regarding the campaign formed to pass a General Obligation Bond, Measure A, on behalf of the Chabot-Las Positas Community College District. Dr. Sperling described how the campaign was based on a direct mail voter contact strategy with no precinct walking or phone banking to voters. Social media was also being applied as a means for conducting voter outreach. Dr. Sperling indicated that the purpose of the call for the Special Meeting was to assess the request by the District to the Foundation for a contribution in the amount of \$10,000. Chair Salinas noted that at a previous Board meeting held on April 29, the members present took up this request. At that time, Dr. Ochoa indicated to the Board of Directors present at that meeting that the MOU agreement between The Friends of Chabot College and CLPCCD expressly prohibited the use of The Friends of Chabot College funds for political campaigns. As a result of that April discussion, Mr. Van Buren had offered to raise the requested contribution on behalf of The Friends of Chabot College. As of May 31, he had raised \$5,000, and Dr. Ochoa had raised \$2,300 for the Measure A bond campaign. Dr. Walter reminded the Board of the MOU provision prohibiting political contributions using Foundation

dollars. Dr. Gin underscored this fact of prohibition by saying, "we do not have money [in the Foundation treasury] that can be used for campaigns." Dr. Kritscher spoke of his personal financial contribution to the Measure A campaign, as did President Sperling. Board Members present decided to individually contribute to the Measure A campaign. Board Members requested that Dr. Ochoa send an email to the campaign coordinator Jessica Harvey indicating that a total of \$8,000 in contributions was being made to the Measure A campaign via the following means: fundraising by Mr. Van Buren and Dr. Ochoa, as well as personal contributions by individual Board Members of The Friends of Chabot College. In the process of discussion, Dr. Walter asked that she be recognized as a voting member of the Board of Directors for The Friends of Chabot College. The matter was held over for discussion to the next meeting of the Board scheduled for June 22, 2016. Motion to indicate The Friends of Chabot College Board of Directors' support for Measure A and their individual commitment to contribute personal funds to the campaign was moved by Ms. Gacoscos, seconded by Dr. Gin. Motion passed with 7 Ayes, 0 Nayes, 2 Absent
